

## National Do Not Call Registry Waiver

As a provider of consumer telephone appending, lists, and related services, CSS is required to obtain and validate customer intentions as related to the Federal Do Not Call Registry. CSS Direct is providing two options to our customers as related to the National DNC Registry.

#### **Option 1 – Receive flagged phones**

CSS Direct will flag all phones that are on the National DNC Registry. This option requires the customer to have a Subscription Account Number (SAN). Customer will only make calls for purposes permitted by law.

#### **Option 2 – Receive all phones**

Customer received un-scrubbed telephone appending, lists, and/or related services from CSS Direct (CSS). CSS will not process customer lists against the National Do Not Call Registry and the State Phone Suppression files, herein collectively called "Telephone Number Suppression files". Customer acknowledges phones on the list may have been placed in a Telephone Number Suppression files. Customers will either obtain access to the Telephone Number Suppression files on its own behalf, or if Customer will not obtain access to Telephone Number Suppression files, Customer will only make calls for purposes permitted by law.
